
1. This Invitation for Tenders follows the General Procurement Notice for Project which appeared in Tanzania Procurement Journal [TPJ] Vol X-No. 30 dated 25th July, 2017 and Tender Portal.
2. The Government of Tanzania has set aside funds for the operation of the Bahi District Council during the financial year 2017/2018. It is intended that part of the proceeds of the funds will be used to cover eligible payment under the contracts for Construction of Water Supply Scheme for Magaga and Mkakatika villages.
3. The Bahi District Council now invites sealed bids from eligible contractors register with CRB in respective classes to bid for the works mentioned below:-

4. Tendering will be conducted through the **National competitive Bidding** procedures specified in the Public Procurement Regulations, 2013 - Government Notice No. 446 and are open to national Tenderers only as defined in the Regulations.

Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the District Tender Board, Bahi District Council office, P.O. Box 2993, Dodoma, email: ded@bahidc.go.tz from 8.00am to 3.30pm on Mondays to Fridays except on public holidays.
6. A complete set of Tendering Document in **ENGLISH** for each lot may be purchased by interested bidders on the submission of a **written application Letter** to the address given under paragraph 4 above and upon payment of a non-refundable fee of **Tanzanian**

Shillings One Hundred Thousands Only (TSHS 100,000.00) or its equivalent in freely convertible "currency". The method of payment shall be in CASH.

7. All tenders must be accompanied by a Bid Security declaration in the format provided in the tendering document.
8. All bids in **one original plus one copy**, properly filled in and enclosed in plain envelopes marked specific tender number, must be delivered to the **Secretary, District Tender Board, Bahi District Council, P. O. BOX 2993, Dodoma** at or before 02.00 p.m (Wednesday) 30th May, 2018. Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend in the opening ceremony at the **BAHI COUNCIL CONFERENCE HALL**.
9. Late bids, portion of bids, electronic bids, and bids not received, bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstance.
