

1. **Bahi District Council** has received financing from the **Embassy of Japan** towards the cost of **Construction of Water Supply Scheme for Kigwe Secondary School** in Bahi District Council and intends to apply portion of the funds to eligible payment under the contract for which this invitation for Bids is issued.
2. **Bahi District Council** now invites sealed tenders from selected eligible and qualified Civil Engineering Contractors to carry out construction works for **Kigwe Secondary School Supply Scheme** in Bahi District.
3. Tendering will be conducted through the **Restricted competitive Bidding** procedures specified in the Public Procurement Regulations, 2013 - Government Notice No. 446 and are open to national Tenderers only as defined in the Regulations.
4. **Selected eligible bidders** may obtain further information from and inspect the Tendering Documents at the office of the **Secretary of the District Tender Board, Bahi District Council office** from 8.00 am to 3.30 pm on Mondays to Fridays from 5th April, 2018 except on public holidays.
5. A complete set of Tender Document in **ENGLISH** for each tender may be **purchased by selected bidders** upon payment of a non-refundable fee of **TSHS 100,000.00 (TANZANIAN SHILLINGS ONE HUNDRED THOUSANDS ONLY)** or its equivalent in freely convertible "currency".

All bids in one original plus one copy, properly filled in and enclosed in envelopes marked specific TENDER NUMBER, must be delivered to THE SECRETARY, DISTRICT TENDER BOARD, BAHI DISTRICT COUNCIL, P.O. BOX 2993, DODOMA at or before 14.00 Hours on 12th April, 2018 (Thursday). Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend in the opening ceremony at the BAHI COUNCIL CONFERENCE HALL.
7. Late bids, portion of bids, electronic bids, and bids not received, bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstance.
